U Rwanda rwihaye intego yo kuba igihugu gifite ubukungu bukinganyiye mu mwaka wa 2035 no kuzaba mu bihugu bifite ubukungu buteye imbere mu mwaka wa 2050(NST1).Imwe mu nzira zo kugera kuri izo ntengo ni uguteza imbere ubuhinzi n'ubworozi hongerwa umusaruro. Ubuhinzi n'ubworozi bukomeze kubangamirwa n'ihindagurika ry'ikirere, indwara z'ibihingwa ndetse n'ubutaka buto bushobora kuba budafite imyunyu ngugu idahagije. Kubw'iyi mpamvu iterambere ry'ubuhinzi risaba kongera inyungu iboneka kuri hegitari, kongera umusaruro no guhinga ibihingwa bitanga inyungu. Hashingiwe kandi ku muhindagurukire y'ikirere urwego rw'ubuhinzi rukwiye gukomeza kubaka ubudahangarwa hitabwa ku uburyo duhinga n'ingamba dufata mu kubungabunga ibidukikije hagamijwe kongera umusaruro byumwihariko gukoresha ikoranabuhanga .

Minisiteri y'Ubuhinzi n'Ubworozi (MINAGRI) ku nkunga y'Ishami ry'Umuryango w'Abibumbye ryita ku Iterambere (UNDP) yageneye inkunga koperative na kampani(Campany) zikora ubuhinzi bw'imbuta, imboga n'ubwatsi bw'amatungo hakoreshejwe ikoranabuhanga ryo guhinga hadakoreshejwe ubutaka(Hydroponic).

Iyi gahunda igamije kongerera abahinzi ubumenyi no gusakaza ikoranabuhanga mu buhinzi hangamijwe kongera ubudahangarwa ku bahinzi, kuza umusaruro no guhanga n'imihindagurukire y'ikirere.



II. Intego nyamukuru y'inkunga

- Kuzamura ishoramari rihamye ku bagore n'urubyiruko mu buhinzi n'ubworozi hagamijwe kugera ku bukungu burambye.
- Gushyigikira ishoramari mu mishanga y'ubuhinzi n'ubworozi izana iterambere rigaragara, hagamijwe kongera umusaruro imirimo no guhangana n'imihindagurikire y'ikirere.

IV. Uburyo inkunga izatangwamo

Umushinga w'ubuhinzi n'ubworozi ugaragaza gahunda yo guteza imbere ubuhinzi bw'imboga, imbuto n'ubwatsi bw'amatungo hakoreshejwe uburyo bwo guhinga hatifashishijwe ubutaka (Hydroponic farming) ku buso buto wujuje ibisabwa kandi watoranijwe n'itsinda ribishinzwe nyuma y'igenzura uzahabwa amafaranga mu uzahabwa mu byiciro inkunga igera kuri miliyoni makumyabiri z'amafaranga y'u Rwanda (20,000,000rwf).

- iv. Koperative/Kampani ikwiye kwerekana kwerekana uburyo umushinga wagiye wunguka nibura mu bihembwe bibiri bishize;
- v. Koperative/Kampani igomba kwerekana ubumenyi bujyanye n'irikorabuhanga, umukozi ushinze gukurikira uyu mushinga ubifitiye ubumenyi cyangwa uburyo azakorana n'abikorera(ubufatanye) bafite ubumenyi muri iri koranabuhanga mu kurimenyekanisha.
- vi. Koperative/Kampani igomba kwerekana uruhare rwayo mu mafaranga buzunganira inkunga.
- vii. Koperative/Kampani igomba kwerekana umubare w'urubyiruko n'abagore bazagira uruhare cyangwa bazagerwaho n'ibikorwa by'uyu mushinga.
